

The real-time identification of open source social media plays a critical role in mitigating and preventing school violence. These reports are a valuable prevention tool for identifying students on the pathway to violence, suicide, radicalization, and/or gang involvement.



In many school violence cases, other students knew about pre-attack planning, and either didn't feel comfortable approaching an adult or were fearful of other students finding out they "told." PSSTWorld provides a solution.

PSSTWorld is an online anonymous reporting tool where students can report anything worrisome directly to SS/TA staff via an online platform (www.psstworld.com). PSSTWorld is accessible from any device with an internet connection. In keeping with the pace of technology, a unique feature of our platform is the ability for students to attach screenshots, pictures, or videos to their submissions. Students are encouraged to report any range of concerning behaviors and incidents that they have seen, heard, or experienced. Submissions are immediately sent to the email inbox of the chosen SS/TA team within the school, school district, or community agency.

PSSTWorld is available in English, French, and Spanish — all within the same platform.

The following training sessions have been designed for law enforcement agencies, school districts, and community partners.

Behavioral and Digital Threat Assessment® (BDTA) Management

8-hour training session



Behavioral and Digital Threat Assessment® (BDTA) management is the first blended multidisciplinary model designed to help Safety/Threat Assessment (S/TA) teams in the early identification and assessment of individuals on the pathway to violence. BDTA® integrates Safer Schools Together's Digital Threat Assessment® (DTA) training and best practice from the National Threat Assessment Center's (NTAC) Behavioral Threat Assessment model which is founded on more than 20 years of research. BDTA® includes a 3-step response plan developed to help S/TA teams ensure all worrisome, concerning, and threat-related behaviors are proactively responded to reducing the potential of violence within your community.

The first step in evaluating a Subject of Concern (SOC) is an initial screener to help S/TA teams identify whether a SOC demonstrates an intent to harm themselves or others. In this session, trainers will examine techniques for identifying and assessing individuals who engage in threat-related behaviors and provide S/TA teams with the tools to ensure a thorough data collection process. Additionally, trainers will provide an overview of the assessment process, including best practices for interviewing, progress monitoring and management.

Participants will obtain the tools vital for proactively and effectively identifying, assessing, and responding to worrisome and/or threat-related behavior through a BDTA® management lens.







- Understand the importance of proactively aligning policy and procedures to best practice for critical incident response and management.
- Become familiar with the Critical Incident Response and Management toolkit
- Identify immediate next steps in developing school and district-based critical incident response and management plans.

Bullying, Cyberbullying & Sextortion

8-hour training session



In this session, we will explore current best practices when supporting those who have engaged in and/or have experienced bullying, cyberbullying, targeted hate, and/or sextortion.

Cyberbullying, targeted hate, and sextortion have become increasingly common due to the rapidly evolving nature of digital communications, especially among today's youth. Due to the complex nature of each of these behaviors, a unique approach is needed to identify and support victims more effectively. We must ensure that we provide relevant education, effective modeling, and coping strategies for all parties. This training provides SS/TA teams with the tools necessary for identifying individuals who may be engaged in, and/or victims of bullying, cyberbullying, targeted hate, and/or sextortion. By the end of this session, you will have a better understanding of how to best support high-risk/vulnerable youth, and the tools to ensure a safe and caring school culture/climate.

- The relationship between school culture/climate and school safety
- The importance of the physical environment in schools
- The differences between bullying, mean behavior, and peer conflict
- Effects of bullying behavior on children and youth
- An interactive case study
- Successful intervention strategies and tools to address different types of bullying
- How to manage social media and the evolution of sexting behavior and sextortion
- Trauma-informed practice – what is trauma, and how does it impact youth?
- The importance of staying connected with high-risk and vulnerable youth and assessing changes in behavioral baseline
- Criteria for program selection and implementation (i.e., social-emotional learning)
- How to design and strengthen school codes of conduct
- How to design for diversity and difference to address homophobia, racism, and systemic racism

- The steps to take to ensure safe and private digital usage

Anxiety, the Brain, and The Classroom: The ABC's of a Trauma-Informed Approach

4-hour training session

The Managing Memorials session offers a snapshot of the full-day Critical Incident Response Training (CIRM), and focuses on clarifying what constitutes a critical incident in schools, how to initially respond both in person and digitally, and best practices for memorials from a trauma-informed lens.

- What constitutes a Critical Incident Response and how it differs from other school and district responses
- The importance of climate and culture
- The key pieces to confirming a critical incident event
- Themes connected to digital responses to critical incidents
- Wise practice for school memory events
- The pros and cons of various memorial models
- Trauma-informed considerations for presentations and memorials

This training is for: School Administrators, District and Staff Critical Incident Teams, Counsellors, Lead Staff, School District Staff, Law Enforcement Agencies, and Community Partners.

Social Media Awareness/Management to Ensure Safe and Caring School Communities

2-hour training session with Q&A



This staff session covers staff and student online safety as well as the permanence of digital tattoos. Now, more than ever, the digital and social media world has flowed into the classroom and school environment. This changing landscape has had positives for learning but has also had many negative implications on a school's culture and climate. This presentation also complements the Positive Behavioral Interventions & Support (PBIS) framework.

This training includes:

- How to recognize and respond to worrisome behavior
- Best practice for staff professional and personal use of social media
- Language of the internet, trends, and inordinate knowledge
- How to continue valuable post-presentation discussion with students

Targeted Hate and Racism: A Restorative Approach Case Study

2-hour training session with Q&A



Our schools and districts are not immune to racism or the difficulties of diffusing tensions that have escalated at provincial/state, national, and international levels. This training will explore recent case studies of scenarios involving targeted hate and racism handled by SST's team of subject matter experts. We will discuss the significance of Digital Threat Assessment® and the importance of regularly assessing social media and other digital platforms for any signs of digital leakage that may indicate targeted hate and/or racism. We will also cover how to apply restorative practices to ensure school connectedness and best practices related to communication and incident management. You will leave this session with a better understanding of how to identify distinct aspects of discrimination as well as hate-related incidents and will receive an Interactive Resource Guide to support your threat assessment response to targeted hate and racism.

This training includes:

- Case Studies involving real incidents of targeted hate and racism and the impact on individuals and communities
- An overview of the key principles and elements of restorative practices, and how they can be applied in the context of addressing targeted hate and racism in school communities
- Strategies to address targeted hate and racism through early identification with Digital Threat Assessment® techniques
- Best practices related to communication and incident management
- Examples of erase Report It / PSSTWorld anonymous student tips

Establishing Safe, Caring and Respectful Digital Communities

STUDENT SESSION*

1-hour educational session



This student session covers all things digital, from being a good digital citizen to the criminal consequences of cyberbullying. Some of the most prominent concerns surrounding students' use of social media platforms and smartphones will be discussed.

This training includes:

- Digital media habits, oversharing, and digital addiction
- The permanence of online posts/activity
- The significance of your digital tattoo in how others perceive you (e.g., sports teams, college admissions, and potential employers)
- The importance of caring for peers both online and offline
- Geo-locational settings and the dangers of social media and cell phone misuse
- The social and legal consequences of cyberbullying behavior as well as possession and distribution of intimate images (sexting and sextortion)

This training is for: Students in Grades 1-12.

Restorative Response to Racism through an Educational Lens

STUDENT SESSION*

1-hour educational session



Our school communities are not immune to racism or the difficulties students face in dealing with the issue outside of the classroom. This session provides expert insight from trainers who have worked in the field of restorative practice in communities affected by racism and hate. While unpacking the positives of discussing racism in our communities, strategies are provided for students to confront racism within their own peer groups. This session will provide take-away activities designed to bring students together and give educators a chance to check in with their class.

This training includes:

- How to promote “anti-racism” within school communities
- The three levels of racism and context/history of what people of color have endured
- What to do when encountering online social media groups related to racism
- The importance of not allowing racist language and jokes to become “normal”
- Why students should stand up, speak up, and protect each other

Peer-to-Peer Student Mentoring Program: Developing Digitally Responsible Learners

STUDENT SESSION*

8-hour training session for students in grade 9 & 10

*Only available as in person training



This training is a school-based peer-mentoring initiative that aims to embrace our youth as valuable and primary resources in prevention and education. Selected students will deliver experiential presentations to their local community schools to address current concerning trends and online use.

Mentors will explore their individual and group values, practice their presentation skills, and develop activities for younger students. Specific focus will be placed on developing digital citizenship skills and appropriately addressing cyberbullying. Through youth-driven peer education, students will explore how the internet and social media can be used appropriately and positively.

This peer-led approach helps communities build capacity and sustainability and enhances the development of digitally responsible learners.

Social Media Awareness, Digital Citizenship, and Cyberbullying

PARENT/CAREGIVER SESSION

2-hour training session with Q&A



This parent session focuses on all things digital. Your child in Middle/High School has now entered the peak of their digital media lives where cell phone ownership doubles, video game use explodes, and social media use becomes problematic. This session will cover recommendations for family rules, parental controls, family tech plans, as well as suggestions for monitoring your tween/teen's digital life.

At this age, children encounter situations that will challenge their independence. Parents have an important role to play in providing support and guidance during critical periods. A snapshot of current trends and concerning apps and platforms will be provided to equip you in your digital parenting strategy.
